

#### **Prof Catherine Hankins**

Catherine Hankins is Deputy Director, Science at the Amsterdam Institute for Global Health and Development, Department of Global Health, University of Amsterdam; Professor of Public and Population Health, Faculty of Medicine, McGill University; and Honorary Professor, London School of Hygiene and Tropical Medicine. She has authored over 250 peer-reviewed publications and reviewed for scientific journals and funding agencies in Canada, USA, and Europe, with extensive experience chairing research review committees. Before joining UNAIDS in 2002, she was

principal investigator of several large epidemiological studies in Canada. As UNAIDS's first Chief Scientific Adviser, she led the scientific knowledge translation team, developing ethical and participatory HIV prevention trial conduct guidelines and convening mathematical modelling teams to support country implementation of proven biomedical HIV prevention modalities. She was the editor of UNAIDS' popular science blog HIV This Week. Professor Hankins chairs the European and Developing Countries Clinical Trials Partnership's Scientific Advisory Committee and the Scientific Advisory Group of the USA National Institutes of Health HIV Prevention Trials Network. She is a trustee of the HIV Research Trust, a member of the International AIDS Society Industry Liaison Forum, and a board member of AVAC. She was named to the Order of Canada in 2013.



#### Prof Michel Kazatchkine, M.D

Michel Kazatchkine has over 30 years experience in the fight against AIDS as a leading physician, researcher, administrator, advocate, policy-maker, and diplomat. He attended medical school in Paris and has completed postdoctoral fellowships at St. Mary's hospital in London and Harvard Medical School. He is Professor of Immunology at Université René Descartes in Paris and has authored or co-authored over 500 publications. Professor Kazatchkine has played key roles in various organizations, serving as director of the national Agency for Research on

AIDS in France (1998-2005), and as French Ambassador on HIV/AIDS and communicable diseases (2005-2007). In 2007, Professor Kazatchkine was elected Executive Director of the Global Fund to fight AIDS, Tuberculosis and Malaria, a position in which he served until March 2012. Between 2012 and 2017, Professor Kazatchkine served as the UN Secretary General's Special Envoy on HIV/AIDS in Eastern Europe and Central Asia. Since 2018, he is the Special Advisor to the Joint UN Programme on HIV/AIDS (UNAIDS) for Eastern Europe and Central Asia. He is also Senior Fellow with the Global Health Centre of the Graduate Institute for International and Development Studies, and a member of the Global Commission on Drug Policy. He holds honorary degrees from Imperial College London, the ULB, the UCL and the University of Geneva.





#### **Dr Alexei Alexandrov**

Current position: Head of the Minsk regional clinical center "Psychiatry-narcology". Education: medical doctor, specialist in public health.

Work experience: psychiatrist and addiction specialist; senior lecturer in the Belarus Medical Academy of Postgraduate Education at the Psychiatry and Addiction medicine, Public Health and Healthcare Management, Primary Heath Care Departments; former chief specialist in addiction medicine of Ministry of Health of Republic of Belarus, former head of consulting department.

Projects and other activities: Harm reduction activities in Belarus and other CEEA countries (projects, seminars, trainings, researches, advocacy campaigns, materials production) in cooperation with international organizations, Belarus Ministries of health and internal affairs and NGO.

Management of opioid substitution treatment programs in Belarus: legislative and methodological support of pilot OST project, scaling up new OST sites, counselling and training for OST specialists.

Member of working group of development Belarus legislation: Narcotic Drugs Law, 2011 (drug prevention, social rehabilitation and narcotic drugs use for medical purposes chapters) and Psychiatric care Law, 2011; previous (2005), current (2010) and revision of national drug treatment guideline (2019). Coordinator of preparation Belarus drug treatment system data to WHO ATLAS on substance use, 2010. Participated as expert at the review of International Standards for Drug Use Disorders, WHO, 2018.



#### Dr Baurzhan Baiserkin

Bauyrzhan Baiserkin, was born November 20, 1966. In 1989, received higher medical education in the field of sanitation, hygiene, and epidemiology.

In 1993, completed clinical residence specializing in social hygiene and healthcare management. From 1989 to 2009 held various positions at the Ministry of Health of the Republic of Kazakhstan and Committee of the State Sanitary and Epidemiological Surveillance. He was engaged in epidemiological surveillance, and control of infectious diseases. In 2010, he received a Ph.D. in public health and healthcare. He worked on the scientific justification for reforming the sanitary-epidemiological service in the public health system in

the Republic of Kazakhstan. In 2015-2018, he headed the Republican Center for AIDS Prevention and Control. He dealt with the reform of the AIDS service in the public health structure, and initiated the creation of the Kazakh Scientific Center of Dermatology and Infectious Diseases through the merger of the Republican Center for AIDS Prevention and Control and the Research Institute of Skin and Venereology. Since January 2019 - Director of the Kazakh Scientific Center of Dermatology and Infectious Diseases. In 2019, a master's degree in public health was awarded. 50 scientific papers, 3 monographs on healthcare organization issues were published. Completed trainings on the basis of Centers for Disease Control and Prevention (CDC, USA), the Center for Social and Economic Cooperation (JACA, Japan), the London School of Economics and Business (London, England), and Charite University Hospital (Berlin, Germany).



#### **Prof Chris Beyrer**



Chris Beyrer MD, MPH, is the inaugural Desmond M. Tutu Professor in Public Health and Human Rights at the Johns Hopkins Bloomberg School of Public Health. He is a Professor of Epidemiology, International Health, Nursing and Medicine at Johns Hopkins. He serves as Director of the Johns Hopkins Training Program in HIV Epidemiology and Prevention Science and as Founding Director of the Center for Public Health and Human Rights. He is the Associate Director of the Johns Hopkins Center for AIDS Research (CFAR)

and of the University's Center for Global Health. Dr. Beyrer has extensive experience in conducting international collaborative research and he has spent much of his career focusing on health and human rights. He was President of the International AIDS Society from 2014-16, and served as International Co-Chair for IAS Science in Vancouver, Canada in 2015, and for the International AIDS Conference in Durban, South Africa, in 2016. He was elected to membership in the U.S. National Academy of Medicine in 2014.



#### **Dr Shakhimurat Ismailov**

Since 2011 Shakhimurat ISMAILOV, professor of the National Scientific Center of Phthisiopulmonology of the Republic of Kazakhstan has been a project manager of the Global Fund to fight AIDS, tuberculosis and malaria on TB component in RK. During the period from 1983 to 2010 he worked in a capacity of a surgeon, research worker, head of pulmonary department, clinic's head doctor, director of NCTP of RK. Over the past 12 years with the support of the Ministry of Health he provided

assistance in attraction of 3 GFATM grant projects to Kazakhstan. From 2017 to 2019 the GFATM grant project "Decrease of M/XDR TB burden in Kazakhstan" is implemented. Since 2007 over \$ 80 million were attracted to Kazakhstan under the Global Fund grants. With the GF support new express methods of TB molecular and genetic diagnostics and M/XDR TB treatment with new and reprofiled drugs were introduced all over the country. In Kazakhstan during the period of implementation of the GF grants' activities from 2009 to 2015 TB morbidity was decreased by 56% and TB mortality was decreased by 67%. General directions of fight against MDR/XDR TB in RK were developed, solid foundations of integration with all partners were extended and laid – PHC, CPCS, HIV services, WHO, GF, USAID, KNCV, NGO and others. During the period from 1984 to 1987 Sh.Ismailov studied at the *Central Scientific Research Institute of Tuberculosis* post-graduate in Moscow and defended his thesis on "Bronchoscopy at the height of pulmonary hemorrhage in patients with tuberculosis and other lung diseases", "phthisiology" code 14.00.27. In 1997 a doctoral thesis under the "phthisiology" specialty on "Bronchoscopy in diagnostics and treatment of TB patients in the common and complicated course of disease" was defended. I prepared 20 candidates and 1 doctor of medical science.

Sergii Dvoriak is a senior researcher at the Ukrainian Institute on Public Health Policy (UIPHP) in Kiev, Ukraine. In addition, Dr. Dvoriak works as a consultant for the World Health Organization (WHO) and United Nations Office on Drugs and Crime (UNODC).

#### Dr Asylkhan Abishev

Asylkhan Abishev was born on January 21, 1969. Graduated from the Almaty State Medical Institute, specialty in General Medicine.

From 1994 through 2009 worked as dermatologist/venereologist, research associate, head doctor of the Clinic at the Scientific Research Institute of Skin and Venereal Diseases. He Worked at the City Center for Prophylactics and Fight against AIDS since 2009 and in the Republican Center for Prophylactics and Fight against AIDS after that. In 2017-2018 served as Acting Director of the Republic's Scientific Research Institute of Skin and Venereal Diseases. Since 2019 to date he is employed as Deputy Director of scientific and clinical work

at Kazakh's Scientific Center of Dermatology and Infectious Diseases. Dr Abishev defended candidate of medical science thesis under "Skin and Venereal Diseases" specialty, code 14.00.11, and was awarded the title of Candidate of medical science. He has authored over 35 scientific papers, participated in the development of 7 clinical protocols, 5 methodological recommendation books, 3 guidelines as well as Ministry of Health orders, including those on HIV/TB, college and university text books chapters on dermatology, venerology and HIV.

#### **Prof Maksut Kulzhanov**





Date of birth: August 10, 1949.

Current position: Deputy General Director of the Republican Center for Health Development of the Ministry of Healthcare of the Republic of Kazakhstan. Place of work: Republican Center for Health Development.

Prof Kulzhanov graduated from the Karaganda Medical Institute, General Medicine specialty, in 1972. Doctor of medical science, topic of his thesis is "Rationale for the Healthcare Reformation Problems during the Transition Period" (1993), became Professor in 2004, became Professor at Virginia Commonwealth

University, USA, 2004. Since 2014 till now he serves as Chair of the Board of the Republican Medical Chamber. 1986 through 2015 worked as chief specialist at the National Center for Expertise of Medicines and Medical Devices; General Director at the Republican Center for Healthcare Development; Rector of Kazakhstan School of Public Health; Deputy Minister of Healthcare, Deputy Director at Scientific Research Institute of Hygiene, Head of the Department of Planning and Prognosis of Healthcare; scientific researcher.

#### Dr Sanimbala Ospanova

Date of birth: November 14, 1966

Sanimbala Ospanova started her education in Saratov State Medical Institute, she later transferred and graduated to Almaty State Medical Institute, General Medicine specialty, 1988-1995.

She completed a postgraduate course and defended dissertation on skin and venereal diseases, specialty code 14.00.11, in 2008, and was awarded candidate of medical science title. Sanimbala worked at the Scientific Research Institute of Skin and Venereal Diseases of the Ministry of Healthcare of the Republic of Kazakhstan, in the capacities of researcher of

allergic dermatosis and congenital skin diseases division, Head of allergic dermatosis and congenital skin diseases division; and Head of venerology division. She is a Senior Lecturer at dermatology, venerology and esthetic medicine division at Postgradute School of Kazakh National Medical University named after S.D. Asfendiyarov (KazNMU).

In 2014-2018 she worked as senior lecturer of dermatology, venerology and dermatocosmetology, additionally delivered a course on allergology and immunology at Kazakh Medical University of Continuing

Education (KazMUNO). Currently works as Head of Scientific Management, International Cooperation and Education at Kazakh Scientific Center of Dermatology and Infectious Diseases.



Dr. Ospanova continues to expand her qualifications, makes scientific publications, participates and organizes conferences and forums, attended Master class Vitiligo Surgery Workshop. Acted as scientific consultant to a Master's degree student, code 6M110100-Medicine, in 2016, academic advisor to a master's degree student, code 6M110100-Medicine, in 2017. Currently supervises post-graduate student applying for the academic title of the Doctor of medical science, code 6D110100 – Medicine, at KazNMU named after S.D. Asfendiyarov.
